CALL FOR PARTICIPATION in SAMBHAV 2023, An International Event of Inclusive Arts

On 18 & 19 November 2023 at India International Centre, New Delhi, India

1. **Sambhav**, in Sanskrit means, something which is possible. The Association for Learning Performing Arts & Normative Action (A.L.P.A.N.A.), a not-for-profit registered organization based in New Delhi, India organizes SAMBHAV as a global platform, to celebrate inclusive arts. Celebrated every year in November since 2006, SAMBHAV is a major international platform of inclusive arts to showcase inclusiveness of global society. Our respected and beloved Prime Minister Sh Narendra Modi articulates inclusiveness of global society with particular emphasis on **DIVYANGJAN** (persons with blessed ability). 2. **ELIGIBILITY:** Applications in the prescribed format are invited from artists (singer / dancer / musician / mime / play / craft person) with disability, to participate in SAMBHAV 2023 to be held at New Delhi from 18- 19 November 2023. Please note that SAMBHAV is essentially for artists with disabilities. NO FINANCIAL SUPPORT FOR MEETING TRAVEL COSTS TO/FROM DELHI WILL BE EXTENDED BY US. WE WILL PROVIDE LOCAL TRANSPORT, SHARED ACCOMMODATION AND FOOD ONLY FOR 17 NOV (ARRIVAL) to 20 NOV (DEPARTURE).

3. **SUBMISSION:** Application, complete in all respects, must reach us on or before 31 July 2023. The applicants should note that submission of theme of performances, sample videos etc., are mandatory. We advise timely submission of applications. The applicant must send scanned copies of filled registration form by email, addressed to Guru Alpana Nayak, President, Association for Learning Performing Arts & Normative Action (A.L.P.A.N.A.) on email address: [alpanasociety@gmail.com](mailto:alpanasociety@gmail.com) .

**4. SELECTION:** Acceptance of registration will be notified by 31 August 2023. The selected participants have to reach New Delhi by the morning of 17 November 2023 for pre-event activities. They should plan to leave New Delhi on 20 November 2023. For the period, 17 November 2023 (check in) to 20 November 2023 (check out by 10 AM), A.L.P.A.N.A. will provide local hospitality (shared accommodation in International Youth Hostel, 5, Nyaya Marg, Chanakyapuri, New Delhi or in similar type of accommodation, depending on availability, food and local transport) to the selected participants and their accompanying care givers whose registration has been accepted and confirmed. As already stated, **NO TRAVEL COSTS SHALL BE MET BY US.**

**5. SAMBHAV ACTIVITIES:** SAMBHAV 2023 will include:

- i. International Seminar on “Divyangjan: Artists with Disability for an Inclusive Society.”
- ii. International Seminar on Yoga, the best gift of Indian culture to the world
- iii. International Yoga Workshop for artists with disabilities

- v. Exhibition showcasing products including handicrafts made by PwDs,
- vi. Exhibition showcasing paintings (Maximum Two Large, Four Medium and Six Small paintings per group), sculptures by PwDs,
- vii. Workshop on handicrafts and paintings for PwDs
- viii. International Workshops on Dance Therapy and Music Therapy for PwDs
- ix. International Event of Performances by artists with disabilities
- x. Heritage Sites exposition for artists with disabilities: INCREDIBLE INDIA INCLUSIVE INDIA
- xi. Interaction visits to schools by artists with disabilities

**6. CATEGORIES OF PARTICIPATION IN SAMBHAV:**

**Category A. Children and Young Performing Artists with Disabilities**

Children and youth who are performing artists (such as singer / dancer / musician / mime / play / painter/ craft person / sculptor) with different kinds of disabilities i.e. visual impairment, locomotor impairment, intellectual impairment, hearing impairment etc. from different countries who will have to put up performances of maximum 15 to 20 minutes duration individually or as part of a group during the SAMBHAV based on selection process of A.L.P.A.N.A. linked to their registration.

**Category B. Experts and practitioners working with Persons with Disabilities**

Gurus, domain experts, dance therapists, music therapists, mental health professionals, medical doctors, art instructors, therapy administrators, researchers, policy makers, diplomats, media persons, legal professionals, rights advocates, students etc. from different countries of the world.

## **Category C. Artists with Disabilities**

Challenged painters, sculptors, weavers, designers, craft persons etc. from different countries of the world, who want to exhibit their arts and artifacts at the international exhibition activity of SAMBHAV.

## **Category D. Managers of organizations working with Persons with Disabilities**

Executives, managers, mentors and leaders of organizations, technologists, technology firms, start-ups including service providers and innovators working for Persons with Disability from different countries.

## **Category E. Caretakers and Caregivers for Persons with Disabilities**

Individuals, groups or firms

## **7. GENERAL INFORMATION**

7.1 The participants have to be present at the venue of SAMBHAV and take part in all activities of SAMBHAV. **They are not supposed to make any other engagements other than SAMBHAV participation during the period of hospitality, i.e. 17 to 20 November 2023.**

7.2 Challenged artists (painters, crafts persons etc) may arrange to bring their exhibition material for display in the exhibition / workshop event.

7.3 The leader/ resource person of the group representing a country will **present a paper on the theme** in the International Seminars. The name of the paper presenter and abstract of the paper should reach us by **01 October 2023.**

### **7.4 Additional information for international participants:**

- i. Individuals or groups falling under any one or more than one Categories (A to E) mentioned above, representing a **COUNTRY**, and willing to travel to New Delhi can participate in SAMBHAV 2023.
- ii. Performances (dance / music) have to be only by persons with disabilities including mentally and/or physically challenged persons.
- iii. For Foreign groups a group of **MAXIMUM FOUR PERSONS** including Challenged Performers (dancers / musicians / singers / mimicry artists /actors) and team leader/ resource person / caretakers (if any) is allowed.
- iv. For Indian groups a group of **MAXIMUM SEVEN PERSONS** including Challenged Performers (dancers / musicians / singers / mimicry artists /actors) and team leader/ resource person / caretakers (if any) is allowed.
- v. A.L.P.A.N.A. has limited funds.
  - **A.L.P.A.N.A. WILL NOT PAY ANY PERFORMANCE FEE.**
  - **ONLY LOCAL HOSPITALITY AS MENTIONED EARLIER WILL BE PROVIDED.**
