#### CALL FOR PARTICIPATION in SAMBHAV 2024, An International Event of Inclusive Arts Also National Exhibition To Showcase Products and Paintings Made By Divyang (PwD) Artists On 20 November & 1 December 2024 at India International Centre, New Delhi, India

**1.** *Sambhav*, in Sanskrit means, something which is possible. The Association for Learning Performing Arts & Normative Action (A.L.P.A.N.A.), a not-for-profit registered organization based in New Delhi, India organizes SAMBHAV as a global platform, to celebrate inclusive arts. Celebrated every year in November since 2006, SAMBHAV is a major international platform of inclusive arts to showcase inclusiveness of global society. Our respected and beloved Prime Minister Sh Narendra Modi articulates inclusiveness of global society with particular emphasis on DIVYANGJAN (persons with blessed ability). 2. <u>ELIGIBILITY:</u> Applications in the prescribed format are invited from <u>artists (singer / dancer / musician / mime / play / craft person/ painter) with disability</u>, to participate in SAMBHAV 2024 to be held at New Delhi from 30 Nov to 1 Dec 2024. Please note that SAMBHAV is essentially for artists with disability. NO FINANCIAL SUPPORT TO INTERNATIONAL PARTICIPANTS FOR MEETING TRAVEL COSTS TO/FROM DELHI WILL BE EXTENDED BY US. WE WILL PROVIDE LOCAL TRANSPORT, SHARED ACCOMMODATION AND FOOD ONLY FOR 29 NOV (ARRIVAL) 2 DEC 2024 (DEPARTURE) PERIOD.

3. <u>SUBMISSION:</u> Application, complete in all respects, must reach us <u>on or before 31 July 2024</u>. The applicants to please note that submission of theme of performance, sample video etc, are mandatory. We advise timely submission of applications. The applicant must send scanned copies of filled registration form by email, addressed to Guru Alpana Nayak, President, Association for Learning Performing Arts & Normative Action (A.L.P.A.N.A.) on email address: <u>alpanasociety@gmail.com</u>.

4. <u>SELECTION</u>: Acceptance of participation will be notified by 31 August 2024. The selected participants have to reach New Delhi by morning of 29 November 2024 for pre-event activities. They should plan to leave New Delhi on 2 Dec 2024. For the period, 29 November 2024 (check in) to 2 December 2024 (check out by 10 AM), A.L.P.A.N.A. will provide local hospitality (shared accommodation in International Youth Hostel, Nyaya Marg, Chanakyapuri, New Delhi or in similar type of accommodation, depending on availability, food and local transport) to the selected participants and their accompanying care givers whose registration has been accepted and confirmed. As already stated, no travel costs shall be met by us for international participants.

- vi. International Workshop on handicrafts and paintings for PwDs
- vii. International Workshops on Dance Therapy and Music Therapy for PwDs
- viii. International Event of Performances by artists with disability

### 6. CATEGORIES OF PARTICIPATION IN SAMBHAV:

# Category A. Performing Artists with Disabilities

Children and youth who are artists (such as singer / dancer / musician / mime / play / painter/ craft person / sculptor) with different kinds of disabilities i.e. visual impairment, locomotor impairment, intellectual impairment, hearing impairment etc. from different states / UTs of India and from other countries who will have to exhibit their products / paintings and put up performances of 20 to 25 minutes duration individually or as part of a group during the SAMBHAV based on selection process of A.L.P.A.N.A. linked to their registration.

#### Category B. Experts and practitioners working with Persons with Disabilities

Gurus, domain experts, dance therapists, music therapists, mental health professionals, medical doctors, art / handicraft instructors, therapy administrators, researchers, policy makers, diplomats, media persons, legal professionals, rights advocates, students etc. from India and other countries of the world.

### Category C. Artists with Disabilities

Challenged painters, sculptors, weavers, designers, craft persons etc. from different states / UTs of India and abroad, who want to exhibit their arts and artifacts at the Exhibition activities of Products and Paintings by PwD activity SAMBHAV.

## Category D. Managers of organizations working with Persons with Disabilities

Executives, managers, mentors and leaders of organizations, technologists, technology firms, startups including service providers and innovators working for Persons with Disability from different countries.

Category E. <u>Caretakers and Caregivers for Persons with Disabilities</u> Individuals, groups or firms

#### 7. GENERAL INFORMATION

7.1 The participants have to be present at the venue of SAMBHAV and take part in all activities of SAMBHAV. They are not supposed to make any other engagements other than SAMBHAV participation during the period of hospitality, i.e. 29 Nov to 2 Dec 2024.

7.2 Challenged artists (painters, crafts persons etc) to come with their exhibition material for display in the <u>exhibition / workhop event.</u>

7.3 The leader/ resource person of the group representing a country will present a paper on the theme, "Empowerment of Artists with Disability" in the International Seminar. The name of the paper presenter and abstract of the paper should reach us by 01 October 2024.

#### 7.4 Additional information for international participants:

i. Individuals or groups falling under any one or more than one Categories (A to E) mentioned above, representing a COUNTRY, and willing to travel to New Delhi can participate in SAMBHAV 2024.

ii. Performances (dance / music) have to be only by persons with disabilities including mentally and/or physically challenged persons.

iii. A group of <u>MAXIMUM THREE PERSONS</u> including PwD Performers (dancers / musicians / singers / mimicry artists /actors) and team leader/ resource person / caretakers (if any) from a country.

iv. A.L.P.A.N.A. has limited funds.

- > ONLY LOCAL HOSPITALITY AS MENTIONED EARLIER WILL BE PROVIDED.
